

SCHOLARSHIP OPPORTUNITY AND GUIDELINES

The Public Purchasing of North Central Texas (PPANCT) is accepting applications from all active members for scholarship opportunities.

This year, PPANCT will award a total of two (2) individual scholarships, not to exceed \$2,500 annually. Scholarship funds can be used for:

2024 National Procurement Institute (NPI) 56th Annual Conference October 13-16, 2024 Denver, Colorado

ELIGIBILITY:

Awarded scholarships may only be given to members of the Public Purchasing Association of North Central Texas in good standing with an active membership.

HOW TO APPLY:

Applicants are required to submit the application form via email to the PPANCT Vice President, Mindy Smith at <u>msmith8@mckinneytexas.org</u>. Applications are due no later than July 5, 2024.

EVALUATION:

The Scholarship Committee is composed of the immediate Past President, the Current President, Treasurer, Secretary, and the Professional Development Chairperson. The Vice President shall serve as the Chairperson of the Committee.

Should a vacancy occur, the President will appoint someone to finish the term of the vacated position. Evaluation of the applications will be completed by the Scholarship Committee.

AWARD:

All awarded funds must be used by the recipient for the conference listed above. Funds that are not used forfeits the recipients' rights to the funds and will be returned to PPANCT.

Documentation such as an invoice, brochure with associated costs, proof of attendance, etc. shall be submitted either in advanced, or upon completion of the educational endeavor.
